Thank you for your correspondence sent to Attorney General Jeff Sessions, dated February 9, 2017, alleging a civil rights violation.

The Criminal Section of the Civil Rights Division is responsible for enforcing federal criminal civil rights statutes. Much of our enforcement activity relates to the investigation and prosecution of deprivations of civil rights under color of law. These matters generally involve allegations of excessive physical force or sexual abuse by law enforcement officers.

We have carefully reviewed the information that you furnished. However, we have concluded that your complaint does not involve prosecutable violations of federal criminal civil rights statutes. This is not a judgment on the truth or merit of your complaint; it is simply to inform you that this is not the type of case that this office prosecutes. Therefore, we regret that we are unable to assist you.

Thank you for your letter, which we received July 23, 2018.

Based on our review of your material, you claim that multiple judges sitting on the Third Circuit Court of Appeals are corrupt and you would like our Office to investigate these judges. This allegation appears to stem from a civil lawsuit you filed in the United States District Court, District of New Jersey surrounding your repeated arrests for illegal placement of signage, failures to appear in court, and driving after a license suspension. The Third Circuit dismissed your claims on appeal.

Unfortunately, at this time, based on our review of your material and limited court records, we will not be referring your matter for federal investigation.
